THIS SUPPLEMENTAL AGREEMENT NO. 1 TO PROFESSIONAL SERVICES AGREEMENT (as "SA #1") is made and entered into this 12 day of January, 2026 (the "Effective Date"), by and between **Greater Miami Expressway Agency** ("GMX"), a body politic and corporate, a public instrumentality and an agency of the State of Florida, existing under Florida Statutes Chapter 348, Part I, as amended, acting by and through its Governing Board, and **A2 Group, Inc.** (the "Consultant"), a Florida corporation located at **12915 SW 132 Street, Suite 5, Miami, FL 33186** and duly authorized to conduct business in the State of Florida, Federal I.D. No. 65-0469324 (collectively, referred to herein as the "Parties" to this SA #1).

WITNESSETH

WHEREAS, GMX competitively procured for all Services necessary to provide **Miscellaneous Construction Engineering and Inspection (CE&I) Services** (the "Services"), and subsequently on **August 19, 2025**, entered into Professional Services Agreement GMX Procurement/Contract No. **RFQ-25-05(A)**, with the Consultant to perform the Services (the "Contract");

WHEREAS, following the Notice of Award on **April 11, 2025**, the Consultant submitted an audit package containing payroll information to establish the Compensation Rates for the Contract based on GMX Established Rate Caps for CE&I Services effective February 1, 2025; and

WHEREAS, GMX is seeking to enter into SA#1 is to formally correct compensation rates for individuals on **Exhibit F-1 – Compensation Rates** to the Contract;

NOW THEREFORE, in accordance with GMX Board approval and Section 8.3 *Approval Authority of Agreements and Supplemental Agreements* of the Procurement Policy; incorporated herein and in consideration of the mutual promises and covenants contained herein, and for such other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties do hereby agree as follows:

1. The foregoing recitations are true and correct and are incorporated herein by reference.
2. **Exhibit F-1 – Compensation Rates** is hereby replaced in its entirety by **Exhibit A – Revised Compensation Rates**, attached hereto.

5. This SA #1 shall not alter or change in any manner the force and effect of the Contract except insofar as the same is altered and amended by this SA #1. Wherever the terms of this SA #1 and the terms of the Contract Documents are in conflict, the terms of this SA #1 shall govern and control.
