

PURPOSE AND SCOPE


A PD&E is a detailed process by which major transportation projects are developed. The objective of this study is to perform preliminary engineering studies to address the transportation and safety needs and to evaluate potential social, natural and physical environmental impacts. MDX will provide continuous public involvement efforts throughout the duration of the study to ensure the public's input in the development and selection of the project alternatives. These studies and the public's input are used to support decisions concerning if and where the improvements should be built. During the study, several alternatives for a connection to I-95 from the Gratigny Parkway will be analyzed and evaluated.

PROJECT BENEFITS

- Alleviate future traffic congestion along NW 119th Street
- Provide better access to the existing highway network
- Reduce travel times and minimize delays by separating through traffic from local traffic
- Provide a critical east-west connection in the northern part of Miami-Dade County
- Provide enhancements to the community which may include the removal of existing lanes, improved pedestrian connectivity, wider sidewalks, lighting, bike lanes and landscaping

PROJECT SCHEDULE

This PD&E Study began in June 2010, and is anticipated to conclude by June 2012. Opportunities for public input will be provided throughout the study as public participation will be an integral part of the process. The PD&E Study is followed by design, right-of-way acquisition and construction.



PROJECT OVERVIEW

MDX has initiated a Project Development & Environment (PD&E) Study for a proposed eastward extension of the Gratigny Parkway to I-95. The PD&E Study will evaluate various alternatives for the extension that will help reduce congestion and improve safety for commuters and residents.
